ELECTION COMMISSION OF INDIA NOTIFICATION UNDER SECTION 150, 30 AND 56 OF THE REPRESENTATION OF THE PEOPLE ACT, 1951 (43 OF 1951) FOR THE BYE-ELECTION TO 202-NANDIGAMA (SC) ASSEMBLY CONSTITUENCY.

The following notification of the Election Commission of India, New Delhi, No. 100/AP-LA/1/2014, dated:20<sup>th</sup> August, 2014 / 29 Shravana, 1936 (Saka) is published:-

**NOTIFICATION**

No.100/AP-LA/1/2014: - **Whereas**, the seat of Sri Thangirala Prabhakara Rao in the Legislative Assembly of the Andhra Pradesh State, elected from 202-Nandigama (SC) Assembly Constituency, has become vacant on 15.6.2014, by reason of death; and

**2** **Whereas**, a bye-election is to be held for the purpose of filling the vacancy so caused;

**3** **Now, therefore**, in pursuance of sub-section (2) of Section 150, and Sections 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby:-

**(A) Calls upon** the said 202-Nandigama (SC) Assembly Constituency in the State of Andhra Pradesh to elect, before the 19<sup>th</sup> September, 2014 (Friday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person of the Schedule Caste of the State for the purpose of filling the said vacancy in the Legislative Assembly of the State; and

- (B) - **Appoints**, with respect to the said election -
- (a) the 27.08.2014 (Wednesday), as the last date for making nominations;
  - (b) the 28.08.2014 (Thursday), as the date for the scrutiny of nominations;
  - (c) the 30.08.2014 (Saturday), as the last date for the withdrawal of candidatures;
  - (d) the 13.09.2014 (Saturday), as the date, on which a poll shall, if necessary, be taken;
  - (e) the 19.09.2014 (Friday), as the date before which the election shall be completed, and
- (C) **Fixes the hours** from **7.00 A.M.** to **6.00 P.M.**, as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
