ORDER :

- x) All the Head Constables of 139-Nandyal Assembly Constituency.
- xi) All the Police Constables of 139-Nandyal Assembly Constituency.
- xii) Any other Police Officers serving for the time being in the Police Department, who are involved in any way in election related arrangements or performing duties in connection with conduct of Bye-Election to 139-Nandyal Assembly Constituency scheduled to be held on 23rd August, 2017.

The above officers are deemed to be on deputation to the Election Commission of India from 29th July, 2017 (Saturday) (ie., the Date of Notification) to 31st August, 2017 (Thursday) (ie., the Date before which election shall be completed) or the date of declaration of result of the said election, whichever is earlier and accordingly they shall, during that period, be subject to the control, superintendence and discipline of the Election Commission of India.

The Director General of Police, Andhra Pradesh, Vijayawada is requested to communicate these orders to all concerned noted under para (1) above and ensure that all the instructions of the Election Commission of India as well as the Chief Electoral Officer are followed scrupulously and to conduct the biennial elections in a free, fair and peaceful manner.
