ELECTION COMMISSION'S NOTIFICATION UNDER SECTION 150, 30 AND 56 OF THE REPRESENTATION OF THE PEOPLE ACT, 1951 - APPOINTMENT OF THE DATES AND FIXATION OF HOURS OF POLL FOR THE BYE-ELECTION TO THE ANDHRA PRADESH LEGISLATIVE ASSEMBLY FROM 14-BANSWADA ASSEMBLY CONSTITUENCY.

The following notification No. 100/AP-LA/2/2011 of the Election Commission of India, New Delhi, dated: the 19th September, 2011 / 28 Bhadrapada, 1933 (Saka) is published:-

NOTIFICATION

No. 100/AP-LA/2/2011:- Whereas, the seat of Sri Pocharam Srinivas Reddy (Parige) in the Legislative Assembly of the Andhra Pradesh State, elected from 14-Banswada Assembly Constituency, has become vacant on 27th April, 2011, by reason of his resignation; and

- 2. Whereas, a bye-election is to be held for the purpose of filling the vacancy so caused; and
- **3. Now, therefore,** in pursuance of sub-section (1) of Section 150, and sections 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby:-
- (A) Calls upon the said 14-Banswada Assembly Constituency in the State of Andhra Pradesh to elect, before the 19-10-2011 (Wednesday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person, for the purpose of filling the said vacancy in the Legislative Assembly of the State; and

- (B) Appoints, with respect to the said election,-
 - (a) the 26-09-2011 (Monday), as the last date for making nominations;
 - (b) the 27-09-2011 (Tuesday), as the date for the scrutiny of nominations;
 - (c) the 29-09-2011 (Thursday), as the last date for withdrawal of candidatures;
 - (d) the 13-10-2011 (Thursday), as the date, on which a poll shall, if necessary, be taken;
 - (e) the 19-10-2011 (Wednesday), as the date before which the election shall be completed, and
- (C) **Fixes the hours** from **8.00 A.M. to 5.00 P.M.** as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
