ELECTION COMMISSION OF INDIA ORDER REGARDING USE OF ELECTOR'S PHOTO IDENTITY CARDS FOR BYE-ELECTIONS TO 39-NELLORE PARLIAMENTARY CONSTITUENCY AND 18 ASSEMBLY CONSTITUENCIES.

The following Order of the Election Commission of India, New Delhi, No. 3/4/ID/2012/SDR/(Bye), dated 28<sup>th</sup> May, 2012 is published:-

**ORDER**

1. Whereas, Section 61 of the Representation of the People Act, 1951 provides that with a view to preventing impersonation of electors, so as to make the right of genuine electors to vote under section 62 of that Act more effective, provisions may be made by rules under that Act for use of Elector's Identity Cards for electors as the means of establishing their identity at the time of polling; and
2. Whereas, Rule 28 of the Registration of Electors Rules, 1960, empowers the Election Commission to direct, with a view to preventing impersonation of electors and facilitating their identification at the time of poll, the issue of Elector's Photo Identity Cards to electors bearing their photographs at State cost; and
3. Whereas, Rules 49H (3) and 49K (2) (b) of the Conduct of Elections Rules, 1961, stipulate that where the electors of a constituency have been supplied with Elector's Photo Identity Cards under the said provisions of Rule 28 of the Registration of Electors Rules, 1960, the electors shall produce

- their Elector's Photo Identity Cards at the polling station and failure or refusal on their part to produce those Elector's Photo Identity Cards may result in the denial of permission to vote; and
4. Whereas, a combined and harmonious reading of the aforesaid provisions of the said Act and the Rules, makes it clear that although the right to vote arises by the existence of the name in the electoral roll, it is also dependent upon the use of the Elector's Photo Identity Card, where provided by the Election Commission at State cost, and that both are to be used together; and
  5. Whereas, the Election Commission made an Order on the 28<sup>th</sup> August, 1993, directing the issue of Elector's Photo Identity Cards (EPIC) to all electors, according to a time bound programme; and
  6. Whereas, the Commission has taken note of the fact that over the last few years since the implementation of the programme of issue of EPICs was taken up, the election machinery of Andhra Pradesh, Tripura and Tamil Nadu, have issued these cards to all electors (100%) in Andhra Pradesh, Tripura and Tamil Nadu; and
  7. Whereas, the Commission has instructed that Authenticated Voters Slips be issued to the electors of 39-Nellore Parliamentary Constituency and 286-Tirupati, 253-Allagadda, 244-Rajampet, 247-Rayachoti, 104-Parkal, 227-Ongole, 127-Narasannapeta, 152-Payakaraopet (SC), 272-Anantapur Urban, 263-Yemmiganur, 267-Rayadurg, 246-Kodur (SC) 242-Udayagiri, 177-Narasapuram, 212-Prathipadu (SC), 161-Ramachandrapuram, 220-Macherla and 186-Polavaram (ST) Assembly Constituencies in Andhra Pradesh, 21-Nalchar (SC) Assembly Constituency in Tripura and 180-Pudukkottai Assembly Constituency in Tamil Nadu, by the election machinery; and
  8. Now, therefore, after taking into account all relevant factors and the legal and factual position, the Election Commission hereby directs that all electors in 39-Nellore Parliamentary Constituency and 286-Tirupati, 253-Allagadda, 244-Rajampet, 247-Rayachoti, 104-Parkal, 227-Ongole, 127-Narasannapeta, 152-Payakaraopet (SC), 272-Anantapur Urban, 263-Yemmiganur, 267-Rayadurg, 246-Kodur (SC) 242-Udayagiri, 177-Narasapuram, 212-Prathipadu (SC), 161-Ramachandrapuram, 220-Macherla and 186-Polavaram (ST) Assembly Constituencies in Andhra Pradesh, 21-Nalchar (SC) Assembly Constituency in Tripura and 180-Pudukkottai Assembly Constituency in Tamil Nadu, for the bye elections notified on 18-05-2012, shall produce their EPICs for establishing their identity before casting their votes. In case EPIC have been lost or misplaced, the Authenticated Voter Slip issued by the election machinery shall alone be the alternative identity document.
  9. Notwithstanding anything in Para 8 hereinabove, in the case of overseas electors who are registered in the electoral roll under Section 20A of the Representation of the People Act, 1950, based on the particulars in their Passport, they will have to produce their original Passport for their identification in the polling station.

The following Order of the Election Commission of India, New Delhi, No. 3/4/ID//2012/SDR/(AP), dated :  
7th June, 2012 is published:-

**ORDER**

In partial modification of Para 8 of the Order dated 28.05.2012, the Election Commission hereby directs that all electors in 39-Nellore Parliamentary Constituency and 286-Tirupati, 253-Allagadda, 244-Rajampet, 247-Rayachoti, 104-Parkal, 227-Ongole, 127-Narasannapeta, 152-Payakaraopet (SC), 272-Anantapur Urban, 263-Yemmiganur, 267-Rayadurg, 246-Kodur (SC), 242-Udayagiri, 177-Narasapuram, 212-Prathipadu (SC), 161-Ramachandrapuram, 220-Macherla and 186-Polavaram (ST), Assembly Constituencies in Andhra Pradesh, for the bye-elections notified on 18<sup>th</sup> May, 2012, shall produce their EPICs for establishing their identity before casting their votes. If any elector fails to produce his/her EPIC, such elector shall have to produce the 'Authenticated Photo Voters Slip' issued by the election machinery. In the case of those electors whose photograph is mismatch either in EPIC or Authentic Voter slip, they shall produce any of the following alternative photo documents along with EPIC or Authentic Voter Slip whose photo mismatched for establishing his/her identity:-

- (i) Passport;
- (ii) Driving License;
- (iii) Income Tax Identity (PAN) Card,

- (iv) Service Identity Cards with photograph issued to its employees by State/Central Government, Public Sector Undertakings, Local Bodies or Public Limited Companies,
- (v) Passbooks with photograph issued by Public Sector Banks/Post Office and Kisan Passbooks (Accounts opened on or before 30-4-2012),
- (vi) SC/ST/OBC Certificates with photograph issued by competent authority on or before 30-4-2012,
- (vii) Pension Documents such as ex-servicemen's Pension Book/Pension Payment Order, ex-servicemen's Widow/Dependent Certificates, Old Age Pension Order, Widow Pension Order with photograph issued on or before 30-4-2012,
- (viii) Freedom Fighter Identity Cards with photograph,
- (ix) Arms Licenses having photograph issued on or before 30-4-2012
- (x) Certificate of Physical Handicap having photograph issued by the Competent Authority on or before 30-4-2012,
- (xi) Health Insurance Scheme Smart Cards with photograph (Ministry of Labour's Scheme), issued up to 30-4-2012,
- (xii) Property Documents such as Pattas Registered Deeds etc. with photograph.
- (xiii) Job Cards issued under NREGA scheme with photograph issued upto 30-4-2012,
- (xiv) Ration Cards with photographs issued on or before 30-4-2012,
- (xv) ATM Cards with photographs issued by Banks on or before 30-4-2012,
- (xvi) Pattadar Pass Books containing photograph issued on or before 30-4-2012.
