ELECTION COMMISSION OF INDIA NOTIFICATION UNDER SECTIONS 150, 30 AND 56 OF THE REPRESENTATION OF THE PEOPLE ACT, 1951 (43 OF 1951) FOR THE BYE-ELECTION TO 186-POLAVARAM (ST) ASSEMBLY CONSTITUENCY.

The following notification of the Election Commission of India, New Delhi, No. 100/AP-LA/25/2012, dated 18th May, 2012 / 28 Vaisakha, 1934 (Saka) is published:-

NOTIFICATION

No.100/AP-LA/25/2012:- **Whereas**, the seat of Sri Tellam Bala Raju in the Legislative Assembly of the Andhra Pradesh State, elected from 186-Polavaram (ST) Assembly Constituency, has become vacant on 02.03.2012, by reason of disqualification vide order dated 02.03.2012 of the Speaker of the Andhra Pradesh Legislative Assembly in Disqualification Petition No.20 of 2011; and

- 2. **Whereas**, a bye-election is to be held for the purpose of filling the vacancy so caused;
- 3. **Now, therefore**, in pursuance of sub-section (2) of Section 150, and Sections 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby:-
- (A) Calls upon the said 186-Polavaram (ST) Assembly Constituency in the State of Andhra Pradesh to elect, before the 18th June, 2012 (Monday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person of the Schedule Tribe of the State for the purpose of filling the said vacancy in the Legislative Assembly of the State; and

- **(B)** Appoints, with respect to the said election -
 - (a) the 25.05.2012 (Friday), as the last date for making nominations;
 - (b) the 26.05.2012 (Saturday), as the date for the scrutiny of nominations;
 - (c) the 28.05.2012 (Monday), as the last date for the withdrawal of candidatures;
 - (d) the 12.06.2012 (Tuesday), as the date, on which a poll shall, if necessary, be taken;
 - (e) the 18.06.2012 (Monday), as the date before which the election shall be completed, and
- (C) Fixes the hours from 8.00 A.M. to 5.00 P.M, as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
