ELECTION COMMISSION OF INDIA NOTIFICATION UNDER SECTIONS 149, 30 AND 56 OF THE REPRESENTATION OF THE PEOPLE ACT, 1951 (43 OF 1951) FOR THE BYE-ELECTION TO 39-NELLORE PARLIAMENTARY CONSTITUENCY.

The following notification of the Election Commission of India, New Delhi, No. 100/AP-HP/1/2012, dated 18<sup>th</sup> May, 2012 / 28 Vaisakha, 1934 (Saka) is republished:-

**NOTIFICATION**

**No.100/AP-HP/1/2012:- Whereas**, the seat of Shri M. Rajamohan Reddy in the House of the People from the State of Andhra Pradesh, elected from 39-Nellore Parliamentary Constituency has become vacant on 28.2.2012, by reason of his resignation; and

2. **Whereas**, a bye-election is to be held for the purpose of filling the vacancy so caused;
3. **Now, therefore**, in pursuance of sub-section (1) of Section 149, 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby:-

(A) **Calls upon** the said 39-Nellore Parliamentary Constituency in the State of Andhra Pradesh to elect, before the 18<sup>th</sup> June, 2012 (Monday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person, for the purpose of filling the said vacancy in the House of the People; and

**(B) Appoints**, with respect to the said election -

- (a) the 25.05.2012 (Friday), as the last date for making nominations;
- (b) the 26.05.2012 (Saturday), as the date for the scrutiny of nominations;
- (c) the 28.05.2012 (Monday), as the last date for the withdrawal of candidatures;
- (d) the 12.06.2012 (Tuesday), as the date, on which a poll shall, if necessary, be taken;
- (e) the 18.06.2012 (Monday), as the date before which the election shall be completed, and

**(C) Fixes the hours** from **8.00 A.M.** to **5.00 P.M.**, as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
