GENERAL ELECTIONS TO H.O.P./ A.P.L.A., 2009 – THE ELECTION COMMISSION OF INDIA IN ITS FAX MESSAGE NO. 56/7/2005-J.S.III/PPS-II, DATED: 26<sup>TH</sup> MARCH, 2009 (COPY ENCLOSED) HAS INFORMED THAT “**COMMUNIST PARTY OF INDIA (MARXIST-LENINIST) (LIBERATION)**” (,) A REGISTERED UN-RECOGNISED POLITICAL PARTY AT PRESENT BUT WHICH WAS A STATE PARTY EARLIER IN THE STATE OF BIHAR (,) PRIOR TO ITS DERECOGNITION AS A STATE PARTY (,) HAVING RESERVED SYMBOL ‘**FLAG WITH THREE STARS**’ IN THE SAID STATE (,) NOT EARLIER THAN 6 YEARS FROM THE DATE OF NOTIFICATION OF THE CURRENT GENERAL ELECTION TO THE LEGISLATIVE ASSEMBLY OF ANDHRA PRADESH(,) HAS REQUESTED THE COMMISSION FOR CONCESSION UNDER PARAGRAPH 10A OF THE ELECTION SYMBOLS (RESERVATION AND ALLOTMENT ) ORDER, 1968 FOR ALLOTMENT OF THE SAID SYMBOL ‘**FLAG WITH THREE STARS**’ TO THE CANDIDATE BEING SET UP BY THE SAID PARTY IN THIS STATE CURRENT GENERAL ELECTION TO THE LEGISLATIVE ASSEMBLY OF ANDHRA PRADESH IN FOLLOWING **7 (SEVEN)** ASSEMBLY CONSTITUENCIES GOING TO POLL IN **FIRST PHASE** OF ELECTION(,)
