C.C.No.189/2008 for the offence under section 143, 188 R/W149 of Indian Penal code

Sec. 143 of I.P.C:- who ever is a member of an lawful assembly, shall be Punished with imprisonment of either description for a term which may extend to six months, or with fine, or with both

Sec. 188 of I.P.C:- Who ever, Knowing that by an order Promulgated by a Public servant lawfully empowered to Promulgate such order, he is directed to abstain from a certain act, or to take certain order with certain Property in his Possession or under his management, disobeys such direction;

Shall, if such disobedience causes or tends to cause obstruction, annoyance or injury, or risk of obstruction, annoyance or injury, to any Person lawfully employed, be Punished with simple imprisonment for a term which may extend to one month, or with fine which may extend to two hundred rupees, or with both;

And if such disobedience causes or tends to cause danger to human life, health or safety, or causes or tends to cause a riot or affray, shall be Punished with imprisonment of either description for a term which may extend to six months, or with fine which may extend to one thousand rupees, or with both.

Sec.149 of I.P.C:- If an offence is committed by any member of an un lawful assembly in Prosecution of the common object of that assembly, or such as the members of that assembly Knew to be likely to be committed in Prosecution of that object, every Person who, at that time of the committing of that offence, is a member of the same assembly, is guilty of that offence.

It is alleged that on 9-08-2006 at about 1.00 P.M., my self and some others staged Dharna farming in to un lawful assembly violating the Prohibitory orders Under Sec.144 of Criminal Procedure Code Issued by Mandal Executive Officer, Proddatur and orders of Police Promulgated in Proddatur Town.

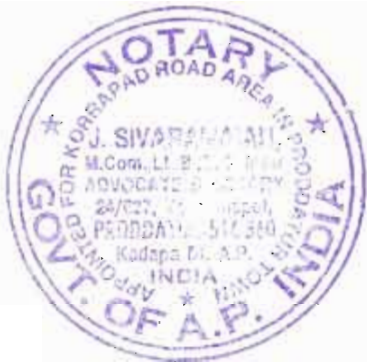
