Sir,

I am directed to invite your attention to the reports of the Returning Officers, the Commission's observers and your letter No.CEO-AP/Spl/Poll Report-1/09, dated 17-04-2009, the subject cited and to state that incidents of destruction of EVMs/poll stopped due to open violence and breach of law and order/failure of machine(s)/procedural irregularity has been noticed at the polling stations mentioned below during poll taken on 16-04-2009:-

After taking all material facts into account and reports of the Returning Officers and Commission's Observers, the Commission has come to the conclusion that the result of the poll taken on 16-04-2009 can't be ascertained within the meaning of sections 58(1) (a), 58(1) (aa) and 58(1) (b) of the Representation of the People Act, 1951 in respect of polling stations mentioned above and declares the poll taken at the above-mentioned polling stations to be void, under section 58(2) of the said Act.

The Commission appoints 18th April, 2009(Saturday), as the date on which a fresh poll shall be taken from 7.00 A.M. to 4.00 P.M. in accordance with the Commission's instructions contained in Chapter-XII of Handbook for Returning Officers (2009).

You are requested to convey this to the District Election Officers and Returning Officers concerned and instruct them to give wide publicity in the areas concerned and inform the political parties and contesting candidates in writing under intimation to the Commission. The Observers should be informed in writing. Instructions given in the Handbook for the Returning Officers be followed scrupulously.

Kindly acknowledge receipt of the letter and confirm action taken.


