1. Time allowed for submission of Accounts of the candidates should be not more than 7 days from the date of declaration of results. The time of 15 days may be allowed for submission of scrutiny report from the date of declaration of results.
 2. The DEO who conducted the Bye-Election was transferred out just before the scrutiny of account of the Candidates. The DEO/RO may not be transferred before submission of reports on election expenditure. The election conducting RO/DEO may be retained in their constituencies till submission of report on expenditure.
 3. The Annexure-15 of the candidates verified only to the extent of information evidence and records available as on today with the DEO.
 4. The Expenditure on account of Paid News has not been incorporated in the accounts since the details of Paid News has not been adjudicated/finalized.
 5. The report in respect of linkage of Cash seizure to the Expenditure of Election contesting candidate has not been done in respect of seizure made by the Police Authorities and Income Tax Dept., since no report has been received. Similarly suspicious transactions in respect of withdrawal of cash has not been linked to the Election Contesting Candidate in absence of reports.
