**ELECTION COMMISSION'S NOTIFICATION UNDER SECTION 150, 30 AND 56 OF
THE REPRESENTATION OF THE PEOPLE ACT, 1951 – APPOINTMENT OF THE
DATES AND FIXATION OF HOURS OF POLL FOR THE BYE-ELECTION TO THE
ANDHRA PRADESH LEGISLATIVE ASSEMBLY FROM 248-PULIVENDLA
ASSEMBLY CONSTITUENCY.**

The following notification No. 100/AP-LA/1/2011 of the Election Commission of India, New Delhi, dated the 11th April, 2011 / 21 Chaitra, 1933 (Saka) is published:-

NOTIFICATION

No. 100/AP-LA/1/2011: - **Whereas**, the seat of Smt. Y.S. Vijayamma in the Legislative Assembly of the Andhra Pradesh State, elected from 248-Pulivendla Assembly Constituency, has become vacant on 08.12.2010, by reason of her resignation; and

2 **Whereas**, a bye-election is to be held for the purpose of filling the vacancy so caused;

3 **Now, therefore,** in pursuance of sub-section (1) of Section 150, and Sections 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby:-

(A) **Calls upon** the said 248-Pulivendla Assembly Constituency in the State of Andhra Pradesh to elect, before the 15th May, 2011 (Sunday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person, for the purpose of filling the said vacancy in the Legislative Assembly of the State; and

(B) **Appoints,** with respect to the said election,-

- (a) the 18.04.2011 (Monday), as the last date for making nominations;
- (b) the 19.04.2011 (Tuesday), as the date for the scrutiny of nominations;
- (c) the 21.04.2011 (Thursday), as the last date for the withdrawal of candidatures;
- (d) the 08.05.2011 (Sunday) as the date, on which a poll shall, if necessary, be taken;
- (e) the 15.05.2011 (Sunday), as the date before which the election shall be completed, and

(C) **Fixes the hours** from 8.00 A.M. to 5.00 P.M, as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
