The District Election Officers & Collectors of Srikakulam, Vizianagaram, Visakhapatnam, Prakasam, Nellore, Chittoor, Kadapa, Anantapur and Kurnool districts of Andhra Pradesh, Mahabubnagar & Ranga Reddy in Telangana and the Commissioner, GHMC & DEO, Hyderabad and the E.R.Os of Srikakulam-Vizianagaram-Visakhapatnam Graduates', Prakasam-Nellore-Chittoor Graduates', Kadapa-Anantapur-Kurnool Graduates', Prakasam-Nellore-Chittoor Teachers', Kadapa-Anantapur-Kurnool Teachers' and Mahabubnagar-Ranga Reddy-Hyderabad Teachers' Constituencies are informed that in the reference third cited, it has been complained that MPDO, Nellore is not accepting the applications in Form-18 though she is designated as Designated Officer by the ERO and denied to accept the application on the ground that she has not yet received instructions.

In this regard, it is informed that detailed instructions have been issued to the DEOs / EROs in connection with the preparation of electoral rolls of Council Constituencies vide references first and second cited. According to ECI guidelines, the Designated Officers are authorized to receive the applications and authenticate the documents submitted by the applicants.

All the District Election Officers / Electoral Registration Officers of Council Constituencies are, therefore, requested to bring the above instructions of the Election Commission to the notice of all the Designated Officers / Additional Designated Officers appointed by the EROs immediately and instruct them to receive the applications / authenticate the documents submitted by the applicants and transmit the same to the ERO/AERO. They shall be cautioned that if any such complaints are received in future, for which action would be initiated against such officers according to the Election Laws.
