I invite your attention to the this office letter 3<sup>rd</sup> cited. As informed therein, as per the directions of the Commission, vide letters 1<sup>st</sup> and 2<sup>nd</sup> cited, all the unrecognised political parties shall submit the following reports to the Chief Electoral Officer, where the party Head Quarters is situated

S. No.	Report	Due date
1.	The contribution reports in Form 24A	30 <sup>th</sup> September every year or such date, as extended by CBDT for filing Income Tax Returns.
2.	The Audited Annual Accounts, with Auditor report	31 <sup>st</sup> October every year.
3.	The Election Expenditure statements attributed to candidates in Annexure-A.	Within 30 days of declaration of result of election.
4.	The Election Expenditure statements (Final).	Within 75 days of completion of Assembly election and 90 days of completion of Lok Sabha election.
