Your attention is invited to the references cited. In view of the Supreme Court
judgment, in the Case of Common Cause Vs Union of India and Others (AIR-1996
SC 3081), the Commission had issued instructions to all political parties to file their
election expenditure statement within 75 days of Assembly election and 90 days of
Lok Sabha elections.

2. It is noticed that your party has not filed expenditure statement for Lok Sabha
and A.P. Legislative Assembly elections 2014 so far, although the due date for such
filing has long expired (11.08.2014 (for APLA) / 26.08.2014 (for HOP)). In this
connection you have already been reminded vide this office letter second cited.

3. Final opportunity is being hereby given to comply with the instructions of the
Commission, for filing the said expenditure statement within a fortnight from date of
receipt of this letter. Your attention is invited to para 16A of the Election
Commission's Symbols (Reservation and Allotment) Order, 1968 which envisages
action against violations of lawful instructions of the Commission. Even if no

3	The Election Expenditure statements	Within 75 days of completion of Assembly election and 90 days of completion of Lok Sabha election
