NOTIFICATION

WHEREAS, in accordance with the provisions of clause (1) of Article 172 of the Constitution of India, the existing Legislative Assembly of the State of Andhra Pradesh, unless sooner dissolved, shall continue up to and including the 18th June, 2019 and shall therefore, stand dissolved on the expiration of its duration; and

WHEREAS, in terms of sub-section (1) of Section-15 of the Representation of the People Act, 1951 (43 of 1951), a General Election has to be held for the purpose of constituting a new Legislative Assembly of the State;

NOW, therefore, as recommended by the Election Commission of India in pursuance of sub-section (2) of Section-15 of the said Act, the Governor of the State of Andhra Pradesh is hereby pleased to call upon all the Assembly Constituencies in the State, to elect members to the

Legislative Assembly of the State, in accordance with the provisions of the said Act and of the rules and orders made thereunder.

NOTIFICATION

No. 464/AP-LA/2019:- WHEREAS, the Governor of the State of Andhra Pradesh has, by notification issued under Sub-Section(2) of Section 15 of the Representation of People Act, 1951 (43 of 1951), and published in the Official Gazette of the State on the 18th March, 2019, been pleased to call upon all the Assembly Constituencies, in the State of Andhra Pradesh to elect members to the Legislative Assembly of the State, in accordance with the provisions of the said Act and of the rules and orders made thereunder;

NOW, THEREFORE, in pursuance of Section 30 of the said Act, the Election Commission of India hereby appoints, with respect to the said election in each of the Assembly Constituency:-

- a) the 25th March, 2019 (Monday), as the last date for making nominations;
- b) the 26th March, 2019 (Tuesday), as the date for the scrutiny of nominations;
- c) the 28th March, 2019 (Thursday), as the last date for the withdrawal of candidatures;
- d) the 11th April, 2019 (Thursday), as the date on which a poll shall, if necessary, be taken; and
- e) the 27th May, 2019 (Monday), as the date before which the election shall be completed.
