ORDER:

The following notification shall be published in an extraordinary issue of the Andhra Pradesh Gazette, dated 15th February, 2007 / Magha 26, 1928 (Saka)

NOTIFICATION

WHEREAS, the Andhra Pradesh Legislative Council Act, 2005 (1 of 2006) was enacted on 11th January, 2006, for the constitution of a new Legislative Council in the State comprising of 90 members – 31 to be elected by Members of Legislative Assembly, 31 to be elected from Local Authorities', 8 from Graduates' and 8 from Teachers' Constituencies; and

WHEREAS, the delimitation of Local Authorities', Graduates' and Teachers' Constituencies was subsequently completed by the Commission and "The Delimitation of Council Constituencies (Andhra Pradesh) Order, 2006" was notified by the President of India on 26th September, 2006; and

WHEREAS, according to the aforesaid Delimitation Order, there are eight Graduates', eight Teachers', fifteen Local Authorities' Constituencies, all of which are single member Constituencies, and the following eight Local Authorities' Constituencies are double members Constituencies :-

(1) Visakhapatnam Local Authorities', (2) East Godavari Local Authorities', (3) West Godavari Local Authorities', (4) Krishna Local Authorities', (5) Guntur Local Authorities', (6) Chittoor Local Authorities', (7) Anantapur Local Authorities', and (8) Hyderabad Local Authorities' Constituencies; and

WHEREAS, the number of Local Bodies and the electors of Hyderabad Local Authorities' and Ranga Reddy Local Authorities' Constituencies will be less than 75%, and the Commission, as per its existing policy, has decided not to hold the election from these two Local Authorities' Constituencies for the time being; and

WHEREAS, the elections have to be held for the purpose of filling the remaining 44 seats from the other Local Authorities', Graduates' and Teachers' Constituencies.

NOW, THEREFORE, as recommended by the Election Commission of India in pursuance of section 15A of the Representation of the People Act, 1951 (43 of 1951), as amended by the Andhra Pradesh Legislative Council Act, 2005 (No.1 of 2006) the Governor of the State of Andhra Pradesh is hereby pleased to call upon each of the said Council Constituencies, specified in column (1) of the TABLE below, to elect the number of member(s), specified against that Constituency in column (2) of the said Table, to the Legislative Council of the State, for the purpose of filling the above seats, in accordance with the provisions of the said Act and of the rules and orders made there under.

Now, therefore, in pursuance of sections 30 and 56 of the said Act, the Election Commission of India hereby –

- (A) appoints, with respect to the said election in each of the Constituencies, -
- (a) the 22nd February 2007 (Thursday), as the last date for making nominations;
 - (b) the 23rd February 2007 (Friday), as the date for the scrutiny of the nominations;
 - (c) the 26th February 2007 (Monday), as the last date for the withdrawal of candidatures;
 - (d) the 17th March 2007 (Saturday), as the date on which a poll shall, if necessary, be taken; and
 - (e) the 26th March 2007 (Monday) as the date before which the election shall be completed; and
- (B) fixes the hours from 8:00 A.M. to 4:00 P.M., as the hours during which the poll shall, if necessary, be taken, on the date specified above, for the election.

The term of the members elected at the above elections shall be determined after the completion of the election in accordance with the provisions of Section 156(1) of Representation of People Act, 1951.
